I. WELCOME

The Executive Board of PT Council welcomes new and returning PTO officers to the 2011-2012 school year. As PT Council Treasurer, I look forward to working with you this year.

PT Council is a 501(c)(3) organization, and acts as the umbrella group for all of our schools' PTOs. We offer all of our member PTO groups tax exempt status and insurance coverage.

II. ADMINISTRATIVE MATTERS

- a. In order to maintain our status with the IRS, it is CRITICAL that our records are kept current.
- b. Goal = to create master file.
- c. Documents needed: Tax exempt letter, current by-laws, copies of tax return, and list of officers.

III. TAX MATTERS

- a. All schools generating *gross income* of \$25,000 or higher, are required to file a tax return form and report to the IRS every year.
- b. Although we all share the same tax-exempt group number (#4229), each school has its own EIN (Employee Identification Number). You must reference this number in all IRS correspondence.
- c. Filing Requirements:
 - Gross receipts of \$50,000 or less may file the "e-postcard" IRS Form 990-N. May also choose to file 990-EZ or 990.
 - Gross receipts < \$200,000 and total assets < \$500,000 may file Form 990 or 990EZ.
- d. Request for Extension of Time – MUST file Form 8868. Gives you an automatic 3 month extension.
